- More Seasoned Professional? Leverage experience & be deliberate


Journey: Chat GPT Released (wow)

- More wow




Journey: Panic

AI Pillars

- Training & Experimentation Everyone needs this skill
- Thought Partnership Expand beyond "Can you write me a blog"
- Agents Al for process driven tasks

Al Pillars – Training & Experimentation

- This isn't something you will delegate to your "AI" person
- Everyone have at least some base knowledge (Just like a computer)
- Every day you should be using some form of Al
- Every day you should be making yourself smarter, faster, and more capable (because everyone else is/will be)

Al Pillars – Thought Partnership

- You are the thought leader, let AI be your partner
- Using AI to Create (Responsibly)
 - Interview You
 - Extract Uniqueness
 - Create and Format Content
 - Use as a tool, not a solution
- Al As a thought partner It can:
 - Leverage you as a subject matter expert
 - Devils advocate
 - Virtual board of directors
 - Bullet Proof Content for any C-Suite decision making
 - Communications Tool
 - Problem Solving Tool

Al Pillars - Agents

- Code brings you through steps
- Al provides a basic level decision making power
- Al adds another set of functions existing code can do... Example, take a simple tool that summarizes content:
 - Code: Go to a URL & Pull HTML.
 - Code: Remove HTML & extract the words
 - Al: Summarize text to 4 bullet points
 - Code: Insert to database
 - Code: Display on a page

Result:

Mass content consumption in a fraction of time

Matt Mullenweg Hires New Lawyer In Fight Against WP Engine via @sejournal, @martinibuster bv: searchenginejournal.com

- Automattic and Matt Mullenweg have hired Rosemarie Theresa Ring, an attorney from Gibson, Dunn & Crutcher LLP, a top law firm in the United States, to represent them in the WP Engine federal lawsuit.
- Gibson, Dunn & Crutcher LLP has a long history of representing high-profile clients, including George W. Bush, Apple, Inc., and Meta and Facebook, in various legal matters.
- Quinn Emanuel Urquhart & Sullivan, LLP, the previous legal representation of Automattic and Matt Mullenweg, is a prestigious international law firm specializing in litigation, particularly in intellectual property, patent, trademark, and copyright law.
- It is unclear whether the previous legal representation, Quinn Emanuel Urquhart & Sullivan, LLP, is still
 representing Automattic and Matt Mullenweg as part of their legal team in the WP Engine lawsuit. Automattic

Meta Threads Takes the Next Step By Launching Ads via @sejournal, @brookeosmundson by: searchenginejournal.com

- Meta is initially testing image ads on Threads with select brands in the United States and Japan, aiming to gauge user response and decide whether to expand the program based on the data collected.
- Users will have control over the ads they see on Threads, allowing them to skip, hide, or report ads they deem inappropriate, and Meta is also testing an Al-powered inventory filter to give advertisers more control over ad placement.
- Advertisers can easily extend their existing Meta campaigns to Threads by checking a box in Meta Ads Manager, although this does not guarantee immediate ad placement due to the limited nature of the test.
- To take advantage of this opportunity, advertisers should start small, monitor their performance, and pay
 attention to how users interact with ads on the platform, keeping an eye on updates from Meta as they expand
 the test. Meta is initially testing image ads on Threads with select brands in the United States and Japan,
 aiming to gauge user response and decide whether to expand the program based on the data collected.

- Google has added 11 new pages to its search quality raters guidelines, focusing on spam and providing additional details, with the last update being for the March 2024 spam update changes over ten months ago.
- Google Ads has introduced new Performance Max features, aiming to provide advertisers with more control, transparency, and actionable insights within Performance Max campaigns, including updates around campaign control, enhanced Search reporting and guidance, and asset group improvements.
- Google's John Mueller stated that spammers encourage users to waste time disavowing links, as Google has said there is little reason to disavow links unless you have a manual action or know you did some bad linking.
- Bing is testing a new local pack design with blue backgrounds, featuring different numbered variations, which
 may change the way local search results are displayed on the platform. Google has added 11 new pages to its

Google Ads To Drop Certification For Some Advertisers & Reorganizes Verification Docs

- The Google Ads Advertiser Verification documentation has been updated and reorganized for improved clarity and readability, effective November 2024.
- Starting February 5, 2025, Google will no longer require certification for advertisers running ads for vignettes/e-vignettes across Europe.
- Advertisers promoting "Business identifiers" exclusively targeting France as a region will still need to apply to be excluded from policy to avoid improper ad disapprovals.




Now What: Seasoned Professionals
